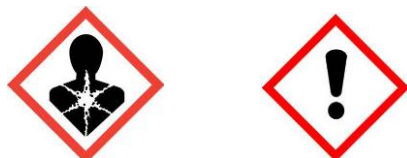

## **SECTION 6 - ACCIDENTAL RELEASE MEASURES**
